TRAPPING GUIDELINES FOR RODENTS

Whilst the use of traps is labour intensive, they have a part to play in rodent control, particularly for controlling very small infestations in circumstances where the use of rodenticides is unacceptable. They are unlikely to contribute significantly to large scale control programmes. The major reason for their limited applicability is the behaviour known as neophobia. If large scale control using traps is essential, then the trapping programme needs to be very intensive and very closely monitored.

The use of break-back traps for both rats and mice is probably the most widespread and successful trapping technique. Careful placement is required with break-back traps, the treadle end of the trap being placed across the rodent run against a vertical surface to minimise avoidance. Bait does not need to be used and may reduce the effectiveness of the trap.

All traps should be visited at least once every 24 hours to remove any dead rodents, reset the traps, and ensure that no rodents are being held alive.

One further form of trapping is the use of 'Glue-boards'. These are sheets of material, such as hardboard or plastic, on which a specially designed sticky substance or 'rodent glue' is spread. The boards are placed in strategic areas of rodent activity in the event that rodents will become stuck on the boards and can then be humanely killed and removed.

Rodent boards should only be regarded as a 'last choice' option.

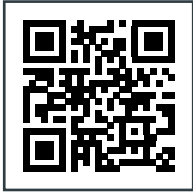
SPRING TRAPS GENERAL USE

The law requires that spring traps must be set in natural or artificial tunnels, to reduce the risk of killing non-target species. Natural tunnels such as burrows roots may be used, or artificial tunnels, about 60 cm long, can be made from turf, rocks, pipes, boards or fallen timber. This tunnel must be large enough to allow the trap's arms to swing and close, but the tunnel entrance should be reduced to a width of suitable size for the target species by driving sticks into the ground, to exclude pets and other wild mammals and birds. Squirrels will investigate such tunnels and catches may be made throughout the year, particularly in winter and spring. Baiting is unnecessary but will improve catches. Traps should be placed with the trigger in the middle of the tunnel and should be bedded in flush with the floor. They should be inspected daily and sprung once a week to prevent seizing due to rust. All traps should be securely anchored.

The Spring Trap Pests Act 1954 makes it an offence to use a spring trap for the purposes of killing or taking animals in England and Wales other than one approved by an Order of the Secretary of State. The approval of traps is a devolved issue.

Traps that are currently approved in England are specified in the latest version of The Spring Traps Approval Order 1995. Only traps that have been approved for the purpose may be used.

Those commonly available from Barrettine are the Fenn MK4 & MK6, BMI Body Grip, WCS Tube Trap, Mole Trap, Talpex, Talpirid and Putange may also be used if available. Spring traps should not be used in areas where protected species such as red squirrels or polecats may be present.

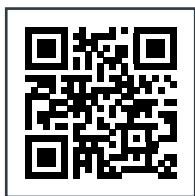

PEST MANAGEMENT ALLIANCE HUMANE USE OF RODENT GLUE BOARDS

Pest Management Alliance - Code of Best Practice - Humane Use of Rodent Glue Boards

In order to protect public health within high-risk environments, the use of rodent glue boards remains an important route if all other options are considered inappropriate. Although rodent glue boards are not designed to physically harm rodents, their use raises valid concerns and they should only be sold to or used by technicians who have been given adequate training and are competent in the effective and humane use of this technique. The following principles must be followed in order to minimise animal welfare concerns:

All interventions aimed at the removal of rodents, including the use of rodent glue boards, have the potential to harm non-target animals and the environment. Although following best practice can mitigate these risks, they cannot be entirely avoided. Therefore, the principal strategy when choosing methods for the control of rodents is to employ the method or methods that have the least potential for adverse impact (i.e. are the least severe and least likely to catch non target animals) but which will be effective in the prevailing circumstances. This is the concept of "risk hierarchy". For more information see the CRRU Code of Best Practice via www.thinkwildlife.org

All other options for rodent control must be carefully considered before rodent glue boards are used. Detailed records must show why other control methods are either considered inappropriate or have failed. Where there is a rodent in a high risk environment, it may be appropriate for rodent glue boards to be placed strategically to ensure immediate control. Use of rodent glue boards should be based on individual risk assessment, but their use should be reviewed every 24 hours.

2. Trained and competent user

Those selecting the use of or using rodent glue boards for rodent control should be trained and competent in their use. This normally means a relevant certification/qualification and familiarity with the Code of Best Practice for their use.

3. Check rodent glue boards frequently

Where rodent glue boards are used these must be inspected at appropriate intervals. This should be within 12 hours of placing, or at least as soon as is reasonably practicable, including weekends and bank holidays. The pest controller may train one or more on-site personnel to check the rodent glue boards at more frequent intervals in order to minimise the rodents' time spent on traps and/or free non-target species, but it remains the responsibility of the pest controller (under the Animal Welfare Act 2006) to deal with any animals trapped on the rodent glue boards, and to revisit at a minimum of every 12 hours.

If unavoidable events cause slight extensions to inspection intervals then the reasons should be recorded. Longer delays must be avoided (see contingency plan below). Where possible and practical, inspection times must be organised to minimise the time rodents are likely to be on the rodent glue board (e.g. if rodents are known to be active during certain periods, inspection times should be arranged with this in mind). The Animal Welfare Act 2006 requires that caught animals must not display any signs of undue suffering, therefore inspections times should be as frequent as necessary to mitigate against this. Records must be updated after all inspections

4. Have a contingency plan

A contingency plan must be in place so that in the event of an emergency a second competent person can be called upon to inspect the rodent glue boards and deal with any captures or safely remove the rodent glue boards as appropriate. Where it is known rodent glue boards will not be inspected at appropriate intervals they must be taken up (even if only temporarily).

5. Use the correct size rodent glue board for the pest species

The size of rodent glue board must be appropriate for the target species.

6. Detailed records

Detailed copies of records and location plans should be available on site at all times for all rodent glue boards laid during any treatment and must be updated as necessary to ensure traceability. Copies ensure information is available should site records be lost or unavailable.

7. Dispatch of trapped rodents humanely

Rodents trapped on rodent glue boards must be dispatched quickly and humanely by technicians with appropriate training in methods of dispatch. Drowning is not an acceptable method of dispatch.

8. Protect non-target animals

Rodent glue boards must be placed in such a manner that they do not present a risk to non-target species. In the event that a non-target animal is trapped, a freeing agent (a suitable food grade oil or similar emollient) should be applied to the animal for removal. If the trapped animal is injured in such a way that release would result in unnecessary suffering, it should be killed humanely. Non-targets should only be released at their site of capture, not elsewhere, and only if they appear to be physically unharmed and their release is not prohibited by law. Ensure when using rodent glue boards that a suitable emollient is available to hand.

9. Remove rodent glue boards at the end of treatment

At the end of treatment all rodent glue boards must be accounted for, removed by the technician and the records endorsed accordingly.

10. Dispose of rodent glue boards safely

Rodent glue boards should be disposed of with care. The sticky surface must be covered to avoid the accidental trapping of any species or subsequent misuse, and the rodent glue board should be disposed of safely and discretely in accordance with legal waste requirements.

11. Communication with the customer

This Code of Best Practice must be provided to the customer to make them aware of the standards to which the operative is working.

The humane use of rodent glue boards is the legal responsibility of the pest controller, and cannot be delegated to untrained people. All technicians must be suitably trained and competent in their application, maintenance and ultimate disposal including the dispatch of the target species and safe removal of non-target species.

This Code of Best Practice was produced after consultation with Defra, APHA, and Natural England.

RABBITS (*Oryctolagus coniculus*)



The most effective time for treatment for control of rabbits is from around November to March when the rabbit population is at its lowest, and the burrows are most accessible. Before treatment, ensure that rabbits lying out in the surrounding area are driven to ground.

Treatment

- 1: With the loaded Phostoxin Applicator, insert one pellet as far into each hole as practicable, usually 30cm (12") is adequate.
- 2: As soon as the pellets have been deposited in the hole, seal the hole with turf, grass side down.
- 3: If fresh rabbit activity is noticed after a few days, repeat the treatment until no further activity is visible.
- 4: Please be aware of the new label changes. Burrows, runs and harbourages can not be treated if they are less than 25 m from any building occupied by man or animals.

MOLES (*Talpa europaea*)



Moles are generally found from sea level to 3,000 ft in many soil types and live almost entirely underground in tunnel systems which consist of main and subsidiary tunnels, whose main purpose is to trap earthworms for food.

Tunnelling is carried out from the nest, which is its sleeping and breeding quarters. Breeding in March and May is the only time moles meet, otherwise, they are solitary animals. Molehills are a problem in lawns, sports grounds and pasture, causing considerable damage to soil and machinery. The mole, who consumes vast quantities of earthworms, can also cause serious disturbance to crop root systems.

Moles are solitary animals and very territorially protective of their area. This can be very misleading when confronted with an area with many molehills, but as a rule, even heavy infestations can mean only eight moles per hectare (three per acre) even in good feeding areas with a high population of earthworms, their primary food.

A GUIDE TO THE BARRETTINE RANGE OF PERSONAL PROTECTIVE EQUIPMENT COSHH AND PPE REGULATIONS

The COSHH Regulations 2002, as amended in 2003 and 2004 are a key part of health and safety at work. The regulations place a legal requirement on all employers and operators including self-employed people to undertake an assessment of the risks created by exposure to any substances hazardous to health. The risk assessment shall include consideration of the hazardous properties of the substance, manufacturers information contained in any material safety data sheet, the level and type of duration of exposure, working circumstances and other factors relating to exposure limits, control measures etc.

The COSHH amendment Regulation 2004 which came into force on 1st April 2005. It introduced a new framework of adequate control of exposure by specifying principles of good practice (Schedule 2A) and by replacing occupational exposure standards (OES's) and Maximum Exposure levels (MEL's) with workplace exposure limits (WEL's).

The Personal Protective Equipment Regulations 1992 require that where PPE is issued it must be suitable for the task for which it is required, and it must take into account the demands it places on the worker. It must be maintained in good condition and stored when not in use in a clean cabinet or container.

What does this mean to you?

The provisions make the duty holders focus on applying principles of good practice to controlling exposure rather than compliance with any OEL. (Schedule 2A)

This has the effect of bringing into the definition of adequate control all substances within the scope of the COSHH regulations, irrespective of whether they have an OEL, and all routes of exposure i.e. inhalation, absorption and ingestion and injection. It is now accepted that it is not possible to give a "Safe limit" as before because in practice a guarantee for health protection for all individuals, even if exposure is below a specified limit, is not scientifically secure.

The revised system of WEL's will be set by the advisory committee on toxic substances (ACTS). These are listed in a publication EH40-2005. There is a specific WEL values in Table 1 for all substances. The WEL value is a limit that must not be exceeded and there is a duty, similar to the previous regulations, to ensure adequate control and to reduce exposure as far as possible.

The amendments to COSHH should make it easier for enforcers and duty holders to determine whether exposures to substances are adequately controlled and proportionate to the risk.

As part of the Barrettine professional services, we have available qualified COSHH Consultants who are able, on a fee basis, to undertake COSHH Assessments and preparation of COSHH documentation for our customers, as well as being able to define the personal protective equipment required in the specific situations encountered by our customers. In addition we are happy for our staff to offer advice, at no charge, on the level of protection required in applying and using any of the products which we offer as part of our Technical Sales Service to our customers.

Schedule 2A

Principles of good practice for the control of exposure to substances hazardous to health.

The eight principles of good practice for the control of exposure to substances hazardous to health are set out in Schedule 2A of The Control of Substances Hazardous to Health Regulations 2002 (as amended). Approved Code of Practice and guidance .

The principles are reproduced below:

- (A) Design and operate processes and activities to minimise emission, release and spread of substances hazardous to health;
- (B) Take into account all relevant routes of exposure - inhalation, skin absorption and ingestion - when developing control measures;
- (C) Control exposure by measures that are proportionate to health risk;
- (D) Choose the most effective and reliable control options which minimise the escape and spread of substances hazardous to health;
- (E) Where adequate control of exposure cannot be achieved by other means, provide, in combination with other control measures, suitable personal protective equipment;
- (F) Check and review regularly all elements of control measures for their continuing effectiveness;
- (G) Inform and train all employees on the hazards and risks from the substances with which they work and the use of control measures developed to minimise the risk;
- (H) Ensure that the introduction of control measures does not increase the overall risk to health and safety. If employers apply the principles correctly, exposure should be below any relevant WEL. Control by personal protective equipment should only be used when other measures are not reasonably practicable. The list of WEL's applies to concentrations of hazardous substances breathed in by the worker and are used to determine the adequacy of control measures. There are several publications, which give advice and guidance on what is required under the COSHH Regulations.

Regulation 7 COSHH 2002. Fit Testing of Facepieces

The performance of RPE with a tight-fitting facepiece (filtering facepieces, half and full full-face masks) depend on a good contact between the wearer's skin and the face seal of the mask. A good face seal can only be achieved if the wearer is clean-shaven in the region of the seal and the facepiece is the correct size and shape to fit the wearer's face. Employers should ensure that the selected facepiece (tight and loose fitting types) is of the right size and can correctly fit each wearer. For a tight-fitting facepiece (filtering facepieces usually known as disposable masks, half and full face masks) the initial selection should include fit testing to ensure the wearer has the correct device. Barrettine can advise customers about this requirement.

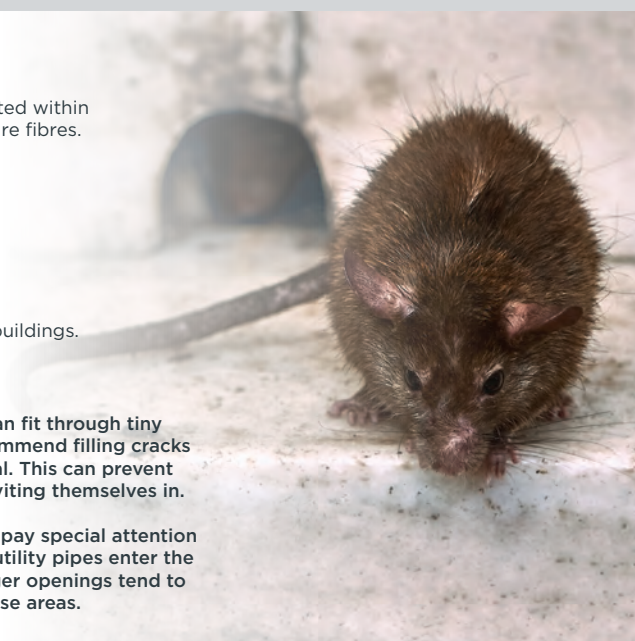

WATER VOLE PROTECTION



KNOW YOUR VOLE

Water voles are easily confused with rats. Rats are treated as pests but water voles are a legally protected species. How can pest control affect water voles? Controlling pests such as rats may lead to accidental destruction of water vole colonies. Damage occurs when water voles are mistaken for rats, or when control methods are used carelessly. Rats sometimes prey on young water voles so careful rat control can benefit water vole colonies.

WHAT THE LAW SAYS

Is it an offence to intentionally or recklessly damage, destroy or obstruct access to any structure or place that a water vole uses for shelter or protection. It is also an offence to disturb a water vole while it is using such a place. (Wildlife and Countryside Act 1981, Schedule 5, Section 9[4]). Blocking water vole burrows is illegal. Placing traps or bait boxes into or in the way of water vole burrows could lead to prosecution. Offences carry a maximum penalty of £5000. The court may also take any vehicle or other equipment used to commit the offence.

THREATS TO WATER VOLES

Water voles have suffered the most dramatic decline of any British mammal in the last century. There is now only one vole for every 20 that were alive in 1900. The main causes for this decline have been loss and damage to habitat, and predation by American mink. Any activity that poses the slightest threat to water voles must therefore be undertaken with extreme care.

THREATS TO WATER VOLES

If you are controlling pests near water, check for signs of water voles before starting. Your local Wildlife Trust may be able to provide information on water vole presence at the site. Both water voles and rats burrow into the banks of most types of waterway. Water voles are usually restricted to within several meters of the water's edge. Use the chart below to check for signs of water voles. If you find water voles and rats follow the advice in the leaflet. If in doubt, contact your local Wildlife Trust.

WATER VOLE (*Arvicola terrestris*)

SIZE & SHAPE	Water voles have rounded bodies and grow to 320 g, smaller than an adult male rat.
COLOUR	Water voles are generally mid-brown in colour with silky fur. Dark brown or black individuals may occur, especially in uplands.
SNOUT, EARS AND TAIL	Water voles have short blunt snouts. Their ears are almost hidden by fur. Their furry tail is two thirds of their body length.
BURROWS	Water voles have short blunt snouts. Their ears are almost hidden by fur. Their furry tail is two thirds of their body length.
PATHS	Usually one main track along water's edge, with some paths pushing up into vegetation higher up the bank. Paths are normally concealed in grass and stay near the water.
DROPPINGS	Between spring and autumn droppings are left in piles of 5-100 usually within 30 cm of water. In winter droppings are dispersed. Droppings are 5-10 mm long and rounded at both ends. They have a putty-like texture, with very fine plant material visible. Green, brown, purplish or black in colour. No strong odour.
FEEDING REMAINS	The diet of water voles is mainly vegetarian. Water voles leave small piles of chopped vegetation (approx. 10cm long and cut at 45 degree angle with grooved teeth-marks at ends) at feeding sites on banks.
ACTIVITY	Can be active during the day but more likely to be seen at dawn and dusk.
FOOTPRINTS	Not a reliable guide.

BROWN RAT (*Rattus norvegicus*)
