**DIRECTIONS FOR USE:** Shake well and remove cap. Point nozzle and apply as a fine dust over the area to be treated. Replace cap after use.

**Ants:** Dust along ant runs and in cracks where ants congregate. Nest entrances should be dusted liberally.

**Wasps:** Apply dust liberally to the nest entrance. Treatment should be carried out in the evening when wasp activity is at its minimum.

**Fleas:** In animal bedding and kennels.

**Lice/Fleas:** To control fleas, a three-step program is needed. First the pets are all treated. Second the home's interior, particularly furniture, carpet, and pets' bedding is treated. Third, the outside perimeter, particularly the pet's habitat must be treated. This treatment must continue until there is no remaining flea population. The home must be thoroughly vacuumed daily before and within 24 hours after treatment. Vacuuming should continue daily for up to two weeks. All pet bedding should also be washed and rinsed in hot water to kill fleas.

To be applied to cracks and crevices where liquid sprays should not be used like areas close to electrical wires and sockets.

**Other Insect Pests:** Apply dust in and around insect hiding places and pathways, paying particular attention to cracks and crevices where insects settle.

Under normal circumstances it should not be necessary to repeat the treatments within 14 days.

Usually persistent control for several weeks can be obtained from one application.
