

MoBe® Ant Gel 4 x 35g

A ready to use insecticidal gel bait for the control of Ants both indoors and outdoors.

TARGET SPECIES: Tropical ants, Argentine ants, *Lasius niger* (black ant). Eggs; larvae; nymphs; pupae and adults.

CONTAINS: Imidacloprid 0.01%, Excipients 100% cps, the product contains a bittering agent.

APPLICATION DOSES AND MODE OF USE: This product should be applied using a measured dose bait applicator. Indoor application: 0.2-0.4g/m². Outdoor application: 0.2g/nest entry or foraging trail; 0.2g/m when applying around a building perimeter. This product can be used continuously for 2 - 3 months without replacing opened bait trays or unconsumed baits. Maximum of 12 applications per year.

AREA OF USE: MoBe® Ant Gel may be used both indoors and outdoors. Direct sunlight and water may reduce the residual effect. Suitable for use in domestic premises including kitchens and bathrooms, restaurants, food preparation and storage premises, as well as public buildings including hospitals and hotels.

PRECAUTIONS: Before treatment, remove all sources of food for ants (waste, food scraps) from the infested area to encourage the ingestion of the gel. Where ants are present indoors, place the gel in drops or thin lines near ant trails, points of entry and their nests. Where ants are present outdoors, place the gel in drops or thin lines in the ant nests or trails. Where presence of ants is only suspected or detected sporadically, it is recommended to use the gel in a bait tray. Check the bait trays once a week. During inspections, check the treated area and if necessary, replace the gel. Do not apply the product on absorbent surfaces. Apply the product away from direct sunlight or heat sources. Inform the authorisation holder if the treatment is ineffective.

STORAGE AND DISPOSAL: Dispose of container/content in a safe way and according to local guidelines/legislation. Shelf-life: 24 months.
