This product contains an anticoagulant substance. If ingested, symptoms, which may be delayed, may include nosebleed and bleeding gums. In severe cases, there may be bruising and blood present in the faeces and urine. Antidote: Vitamin K1 administered by medical/ veterinary personnel only. In case of: Dermal exposure, wash skin with water and then with water and soap. Eye exposure, rinse eyes with eye-rinse liquid or water, keep eye lids open for at least 10 minutes. Oral exposure, rinse mouth carefully with water. Never give anything by mouth to an unconscious person. Do not provoke vomiting.
