Thoroughly agitate the container well before opening. Half fill the spray tank and commence agitation before addition of the required quantity of Liquid REZIST. Add the remaining quantity of water and continue agitation until spraving is completed. Do not leave in the sprayer without agitation.

Wash out all equipment thoroughly after use.

COMPATIBILITY: Do not apply REZIST LIOUID with any other products.
