





Directions for Use


Initial Assembly




Step 1: Push the tablet gently but firmly into the dispenser, leaving approximately 50% of the tablet exposed.



Step 2: Remove plastic protection from the sticky mounting on the back of the dispenser.



Step 3: Press the dispenser, tablet upper-most on to a clean surface.




Correct Mounting of Tablet & Dispenser.

Tablet Replacement

Step 1: Carefully peel grip-lock to detach the dispenser.

Step 2: Push out the old tablet from the rear of the dispenser.

Step 3: Replace the new tablet and secure the dispenser into position (steps 1 & 2).



Deployment Guide

A pack of 24 tablets is sufficient to treat 600 m² (1 tablet = 25 m²)

For areas up to 50m²: Position the dispensers around the edges of the room 5m apart utilising wall surfaces where possible. **For areas greater than 50m²:** Position dispensers in a grid format 5m apart. Start from the edges of the room utilising wall surfaces first. Distribute remaining tablets throughout treatment area on other suitable surfaces and structures.



Deployment Grid 5 -10m

Avoid placement directly above exposed product or within 2m of pheromone monitoring traps.

Replace tablets every two months to ensure continued performance.

Use extra tablets around known pest hotspots or problem areas.

PEST MONITORING: Monitoring traps should be used throughout the treatment area to assess the level of infestation. Over time a reduction in moth numbers caught in monitoring traps will indicate that the system is working. Individual monitoring traps will provide warning of infestation hotspots, pinpointing areas requiring remedial action.

The INSECTRAC system is a prophylactic treatment and should not replace good hygiene practices.

A solid formulation pellet containing 5mg/g Clothes Moth pheromone blend.

Contact with eyes: In case of contact, immediately flush eyes with copious amounts of water for at least 15 minutes. If symptoms persist, seek medical attention.
