Cases of severe poisoning may require the usual measures like application of blood products or transfusions. Recovery is spontaneous and without sequelae. In case of ingestion gastric lavage should be considered in cases of significant ingestions only within the first 2 hours. However, the application of activated charcoal and sodium sulphate is always advisable. Symptoms of poisoning may appear several hours later.
